**1. General**

- A. User Agreement: By completing the registration process, returning the Partner Plus document to Capitol Christian Distribution, a division of Capitol Christian Music Group, Inc. ("Capitol Christian Distribution") and using the Capitol Christian Distribution website (the "Website"), you are indicating that you are 18 years or older, that you have the complete authority to enter into this Agreement on behalf of yourself and your company, and that you and your company agree to be bound by all terms in this User Agreement. Continued acceptance of this agreement is a condition of your account with the Website. Capitol Christian Distribution reserves the right to change, modify, and/or remove portions of this User Agreement at any time without notice or liability, and such modifications shall become effective upon your use of the Website after posting on the Website and/or electronic transmission to you. If this User Agreement, or any changes thereto, are unacceptable to you or your company, or cause you or your company to no longer be in compliance with the User Agreement, you should not use the Website again and should cancel your account according to the procedures specified in the registration process.
- B. The Website: The Website will contain four (7) primary and separate areas, all of which will be accessible on a restricted basis only (as more fully explained below):
1. Order Status section
  2. Place an Order section
  3. Stock Check section
  4. Return Request section
  5. Account Status section
  6. Policies and Procedures section
  7. "ONDeal Promotion" section
  8. Updates and Alerts
  9. Invoice Copies
- C. Levels Of Access: There are three (3) levels of access to the Website, all of which shall be limited to the particular store of the user.
1. **Partner Level** (intended for clerks and so-called "frontliners") shall be provided access to New Release product information, Policies and Procedures Updates and Alerts, Invoice Copies and Order Status. Users can

obtain access to Partner Level by filling out the online registration in its entirety. NO contract is needed for Partner Level access.

**2. Partner Plus Level** (intended for music buyers and managers) shall be provided access to New Release product information, Policies and Procedures, Updates and Alerts, Invoice Copies, Order Status, Place an Order, Stock Check, Return Request, and ONdeal sections. Capitol Christian Distribution will provide (and may revoke) levels of access based upon the written direction of the manager/owner of each store. Capitol Christian Distribution must receive a signed contract in order to grant access to restricted sections with the Partner Plus Level.

**3. Partner Plus Advanced Level** (intended for store owners and managers) shall be provided access to New Release product information, Policies and Procedures, Updates and Alerts, Invoice Copies, Order Status, Place an Order, Stock Check, Return Request, and ONDeal and Account Status sections. Capitol Christian Distribution will provide (and may revoke, as provided herein) levels of access based upon the written direction of the manager/owner of each store. Capitol Christian Distribution must receive a signed contract in order to grant access to restricted sections with the Partner Plus Advanced Level.

D. Representations and Warranties: Capitol Christian Distribution expressly disclaims all implied warranties, including, without limitation, warranties of merchantability, title, fitness or a particular purpose, noninfringement, security or accuracy. Capitol Christian Distribution bears no responsibility for errors in the software program(s) used in connection with your downloading, unencoding ("browsing") or otherwise interpreting information provided by Capitol Christian Distribution via its electronic communications equipment.

## **2. Privacy**

A. Consent: By executing this Agreement, you are agreeing that Capitol Christian Distribution may store information you provide as part of the registration process and usage information, and may make use of aggregate statistical information without personal identifying information, as detailed more fully in the "Capitol Christian Music Group Internet Privacy Policy." Capitol Christian Distribution may also use the information to inform you about other Capitol Christian Distribution products and services, unless you opt not to receive such information.

B. Disclosure: Capitol Christian Distribution's general policy prohibits the disclosure to third parties of any specific personal identifying information, i.e., your name, address, telephone number or e-mail address. Capitol Christian Distribution will not disclose such information to third parties without your prior consent.

C. Future Communication: Capitol Christian Distribution reserves the right to send electronic mail to any and all users. You may always elect to not receive electronic mail from Capitol Christian Distribution by unsubscribing as directed in the electronic mail you have received.

### **3. Registration with Website; Use of Website**

- A. User Duty: You must keep your password private and not provide it to third parties or co-workers. You are responsible for all statements made and acts or omissions that occur while your password is being used. Until Capitol Christian Distribution is notified of a breach of security, or is otherwise instructed by the manager of your store to cancel your registration, you will remain responsible for any unauthorized use of your account. In no event shall Capitol Christian Distribution be responsible for any information divulged or actions taken by any party's unauthorized use of your password. You shall promptly advise Capitol Christian Distribution of any changes in personnel in order to keep your user status current at all times.
  
- B. Choice of Password: Capitol Christian Distribution may refuse to grant you a user name that is already taken, impersonates someone else, is protected by trademark or other proprietary right law or is vulgar or otherwise offensive, in the sole judgment of Capitol Christian Distribution.
  
- C. - E. Annual Confirmation of User Status: On an annual basis, each user shall be required to review and confirm, or revise, as applicable, his or her account information in order to ensure the continued validity and accuracy thereof.

### **4. Copyright, Trademark and Restrictions**

- A.
